



The development concept and the Implementation program of the Single Window system for export-import and transit procedures


- A Single Window Coordinating council has been established consisting of the representatives of the controlling state agencies at the border.
- A State unitary enterprise "Single Window Center" has been established under the Customs service under the Government of the Republic of Tajikistan:
- Implementation of the Single Window in the Single automated information system of Tajikistan customs authorities
- Expected effect from the implementation of the Single Window: creation of a single interagency automated system for information collection, storage and processing during all types of foreign trade transactions at the border. Combining document control for the goods transported over the border at the border crossing points, improving the quality and reducing the time for goods inspection and release.

#### Decisions of the Government of the Republic of Tajikistan


- Resolution of the Government of the Republic of Tajikistan dated October 1 2008 No 487 "On the approval of the Plan of actions to simplify the administrative barriers for export, import and transit of goods":
- Resolution of the Government of the Republic of Tajikistan dated April 3 2012 No 155 "On the coordination of controlling agencies at the road border crossing points at the customs border of the Republic of Tajikistan following a one-stop-shop principle";
- Resolution of the Government of the Republic of Tajikistan dated June 3 2014 No 155 "On the rules of coordination of controlling agencies at the road border crossing points at the customs border of the Republic of Tajikistan following a one-stop-shop principle".
- Resolution of the Government of the Republic of Tajikistan dated September 2 2014 No 567 "On the rules of information exchange between state entities and other organizations authorized to make decisions to issue permissions and certificates for import, export and transit of goods following the Single Window principle to traders.

#### The proposed border crossing point procedures





Ways to simplify border crossing procedures at the level of the customs service

- Simplifying the requirements for the documents produced at the border.
- Information exchange between the customs services on the requirements for traders to ensure their compliance with the requirements of other countries.
- Mutual recognition of the customs and other documents in the Central Asian region.
- Conducting joint (international) control following the "single window/one-stop-shop principle".
- >Apllying state-of-the-art technical customs control means.



#### Expected reform outcomes

- > reducing the time spent by the traders during border crossing;
- increasing the throughput capacity of the border crossing points of the Republic of Tajikistan by commissioning new and modernizing existing border crossing points;
- > promoting the implementation of an effective trade policy and investment promotion;
- > prevention and reduction of corruption-related violations in the activities of controlling entities.
