

Legislative reforms

New Customs Code

Entered into force on January 1, 2012

The Code reflects the provisions of the Kyoto Convention, the WCO SAFE Framework of Standards and other international norms.

New concepts:

- Use of information technology in customs;
- Electronic payments and services;
- Intellectual property rights;
- AEO's
- Modernized customs procedures.



STATE CUSTOMS COMMITTEE OF THE REPUBLIC OF AZERBAIJAN

Requirements for the users of Green Corridor

01

Preliminary electronic declaration (at least 1 hour before the entry of the goods to BCP);

02

Immediate notification of customs authorities upon arrival of the goods to the importers warehouse

03

Submission of electronic export declaration at least 1 hour before the loading goods into the vehicle

04

Accurate declaration of information on goods and vehicles (range, quantity, technical specifications, designation, HS code and value)

05

Provision of guarantees provided in the Customs Code (Article 258.1) for the purpose of ensuring payment of customs duties that may arise during the import transactions or in future

06

Transportation of the goods by means of transport that meets safety standards, where external interference is impossible





Suspension of the right of use of the "Green corridor"

The suspension the

right of use

If the application on suspension is submitted to Customs Committee by the user of "Green Corridor" (in this case user right shall be suspended for a period no more than 12 (twelve) months)

In case of failure to comply with the requirements (in this case user right shall be suspended for a period of 3 (three) months)

Customs within of 1 working day shall notify the user and relevant authorities on decision of suspension of the user status. The Committee shall inform the individual at least 30 (thirty) days before making a decision on that.

Within 1 working day from the date of the decision on restoration of the right to use "Green Corridor", the person and other relevant authorities shall be informed.

Revocation right of use

01 If the application on revocation is submitted to Customs Committee by the user of "Green Corridor" 02 If misinformation found in documents submitted for the right of use of the Green Corridor In the case of repeal of legal entity or if individual is considered incapable by a court, 03 or in case of individuals death 04 If the user does not carry out an import-export operations within 12 (twelve) months 05 *Conviction for crimes such as smuggling, evasion of payment of customs duties etc.*

06

If the reasons of suspension of the right to use the Green Corridor are not eliminated.

Customs within one (1) working day from the date of adoption of the decision on termination of the right of use of the Green Corridor shall notify person and other relevant authorities..

National AEO Programme:

«Rules of assignment, temporary suspension and cancellation of the status of Authorized Economic Operator»

Resolution No. 230 of the Cabinet and Ministers of the Republic of Azerbaijan dated August 27, 2013

The main criteria's for assigning AEO status are:

- Compliance with the rules;
- Record keeping system;
- Financial viability;
- Security.

Terms for granting the AEO status are as follows:

- existence of possibility of ensuring the delivery of goods to the destination in accordance with the safety norms and standards specified by the World Customs Organization;

- to comply with the requirements of customs and tax legislation;

- to have a satisfactory system on management of commercial and transport documents, playing an important role in terms of customs control;

- to have financial capacity to carry out customs duties and other payments;
- to have at least 2 (two) years of experience in the field of operation;

- to have possibility of implementation of the relevant safety and security standards;

- to have a technical base ensuring exchange of information at the proper level.

Further plans:

- Appointment of AEO working group
- Amendment of legislative acts (Customs Code and Resolution No.230)
- Develop the application form, self-assessment form, benefits, AEO manual, guidelines (security and validation)
- Enhancement of outreach programs (workshops and trainings both for customs and private sector)
- Create a separate AEO section and make available all the relevant information at the website
