Country's experiences in business process review and document standardization

Trade Facilitation



One of the key drivers of economic development is the promotion and facilitation of legitimate trade. The Customs Service promotes trade and development of international transport corridors by: introducing modern technologies; using innovative equipment, software; using international digitalization tools; improving customs operations in accordance with international standards and recommendations.



Project "Single Window for Export-Import" in Turkmenistan The Single Window Mechanism is a trade facilitation measure and the foundation for paperless trade;

In 2021, the State Customs Service of Turkmenistan in cooperation with UNCTAD and UNDP launched the "Single Window for Export-Import Operations" project in Turkmenistan;

The project will allow persons engaged in foreign economic activity to be able to provide the information necessary to fulfill all the requirements of import and export laws through one-time submission in one system, which in turn will speed up and simplify customs clearance of goods;

22 ministries and sectiral departments of Turkmenistan participate in the Project.



Action plan for the implementation of the "Single Window" system Preparatory stage

A clear plan and sequence of actions have been developed under the Project. The action plan includes 3 stages:

- Preparatory;
- Development of a prototype;
- Implementation.

The preparatory stage was successfully completed, during which the following were established:

The Interdepartmental Commission – consists of the leadership of the relevant state controlling agencies (hereinafter referred to as the SCA) involved in the work of the "Single Window" The Interdepartmental Working Group – consists of lawyers, IT specialists and functional employees. Action Plan for Single Window Implementation Development of the Prototype

The "Prototype Development" stage is the most important stage in which **the business process review** and the decisions made based on its results play a key role.

The Single Window mechanism should reflect the current business processes

In cooperation with UNCTAD specialists, a functional and technical review of the SCA business processes in the field of issuing permits during customs clearance of goods was carried out



"Prototype Development" Stage Business process review


The review consisted of 4 steps:

- 1. Collection of background data on the current work of the SCA;
- 2. Analysis of the collected data;
- 3. Findings and recommendations;
- 4. Process reorganization.

This stage has also been successfully completed.

Work has been carried out to improve the customs legal framework;

- The concept of the system "Single window for export-import operations" paragraph 29 Part 1 Article 5 of the Customs Code of Turkmenistan;
- The requirement for standardization of documentation Part 5 Article 7 of the Customs Code of Turkmenistan

Action Plan for implementation of the "Single Window" system. Implementation Stage

- Key activities at the Implementation Stage:
 - Organization of courses
 - System piloting
 - System launching
 - Testing of the Interdepartmental RMS
- The work under this stage is being actively carried out for the successful implementation of the Project in the country
