











SINGLE WINDOW





In order to gradually cover all procedures related to foreign economic activity, the system "Single Window" introduced a procedure for issuing 60 types of documents of permissive nature 12 bodies.





For reference: at the moment the system registered more than 55 thousand participants in foreign economic activity, which authorized bodies issued more than 1.2 million permits.



RISK MANAGEMENT SYSTEM



Previously, the registration of the cargo customs declaration took 2-3 hours, but as a result of automation of the process now it takes 2 minutes.

Risk Management System from June 1, 2020 at road border crossings, and from June 30, 2021 also implemented at the border rail checkpoints.



Through this system:

Green Channel - 32.4%

Yellow channel-62.3%

Red channel - 5.3%

goods are processed.

As a result, the time of customs clearance was reduced from 3 three days to 1 working day.


Operations related to submission and execution of transit declaration to customs authorities shall be carried out through the automated information system "E-Transit" of the Customs Committee


Ninety-eight import and export procedures by road, rail and air for 49 commodity groups were documented.




ELECTRONIC QUEUE - WWW.E-NAVBAT.CUSTOMS.UZ

E-Navbat system - introduction of electronic queuing at border customs posts






Step 5. "Complete the process". After passing all stages, the system will give the order number. Upon arrival, based on the selected day and time, the order number will be presented to the customs officer for review
