Eighth Transport Sector Coordinating Committee Meeting 24–25 June 2009, Ulaanbaatar, Mongolia

SUMMARY OF DISCUSSION

I. Introduction

1. The Eighth Transport Sector Coordinating Committee (TSCC) Meeting (the Meeting) was convened on 24–25 June 2009 in Ulaanbaatar, Mongolia. Delegations from all eight CAREC countries and representatives of international organizations and other development partners including the Asian Development Bank (ADB), European Bank for Reconstruction and Development (EBRD), Japan International Cooperation Agency (JICA), United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP), and World Bank participated in the Meeting. The Meeting agenda and the list of participants are in Appendix 1.

II. Implementation of the Action Plan for the Transport and Trade Facilitation Strategy

- The Meeting reviewed the implementation status of the Action Plan. All eight CAREC 2. countries presented the salient progress made to date. The Meeting noted substantial progress made during 2008-2009, covering all CAREC Corridors and focusing on CAREC transport infrastructure. Regional roads totaling about 900 km were improved or constructed and regional railways totaling about 700 km were rehabilitated or electrified in 2008. Out of 63 investment projects, 48 investment projects are either completed or ongoing, constituting 93% of the total investment amount in the Action Plan. Out of 49 technical assistance (TA) projects, 19 TA projects have been completed or ongoing, amounting to 24% of the total TA amount. Five major investment projects totaling \$9.2 billion started along Corridors 1b, 1c, 2, 4a, and 4b. Eleven investment and TA projects have been completed during 2008-2009 and four new projects have been added to the Action Plan. Regional projects have been consolidated from 40 to 19, to give clearer focus on activities. The Kyrgyz delegation shared the updated information on the China-Kyrgyz Republic-Uzbekistan railway project. The Tajikistan delegation requested more civil aviation activities in the Action Plan, particularly civil aviation safety training programs, considering recent accidents and increasing international emphasis on civil aviation safety. The Mongolian delegation requested to include the Hovd airport and a TA project on an access road to the ongoing international Ulaanbaatar airport in the Action Plan. The TSCC Secretariat is reviewing investment and TA projects in Inner Mongolia Autonomous Region, Peoples' Republic of China, which will be included in the Action Plan.
- 3. The Meeting commended the achievements made in the CAREC countries and the quality of the country progress reports. It discussed financing opportunities and issues related to the implementation of the Action Plan such as financing for AZE IP 3: Acquisition of High Capacity Ferries and Ro/Ros by Caspian Sea Shipping, KGZ IP 7: Rehabilitation of Osh Airport, and KGZ IP8: Kyrgyz Air Traffic Control Enhancement. EBRD and JICA were requested to review financing possibilities for these projects.

4. The Meeting endorsed the Progress Report for submission to the Ministerial Conference on CAREC scheduled for October 2009 for information, after incorporating comments provided during the Meeting (Appendix 2).

III. Thee-Year Rolling Plan (2010-2012)

5. The TSCC Secretariat presented a draft Three-Year Rolling Plan (the Rolling Plan) for 2010-2012. The Rolling Plan comprises 14 investment projects amounting to \$1.7 billion and 28 TA projects totaling \$51.7 million. The participants provided comments and endorsed the revised Rolling Plan for submission to the Ministerial Conference for information (Appendix 3).

IV. TSCC Work Plan for 2009 and 2010

- 6. The TSCC Secretariat presented the Work Plan for 2009 and 2010. The Work Plan for 2009 includes (i) contributing to development of CAREC Results Framework; (ii) submitting to the Ministerial Conference the Progress Report and Three-Year Rolling Plan (2010-2012); and (iii) arranging training on road safety (Almaty, September) and regional transport project implementation (ADB Headquarters, October). TSCC Secretariat will present Corridor 1b at the next Ministerial Conference.
- 7. The major activities of 2010 are (i) Ninth TSCC Meeting; (ii) Progress Report and Rolling Plan (2011-2013); and (iii) training on road safety and regional transport project implementation support. The TSCC will make a presentation on Corridors 3b, 6a, and 6c at the Ministerial Conference in 2010. The Meeting acknowledged the 2009 Work Plan activities and endorsed the 2010 Work Plan (Appendix 4).

V. Database for Transport Performance Indicators

8. The Meeting reviewed four indicators and approved them for monitoring transport sector performance. The indicators are (i) roads constructed or improved, (ii) railways constructed or improved, (iii) number of airports built or improved, and (iv) number of cross-border facilities improved or upgraded. The performance parameters for the remaining period of the Action Plan implementation (2010–2017) will be further improved, incorporating the updated information which the CAREC countries will submit to the TSCC Secretariat by 16 July 2009 by using the formats provided by the TSCC Secretariat (Appendix 5).

VI. Development Partners' Activities

9. EBRD, UNESCAP and the World Bank made presentations on their activities related to CAREC transport program. The participants were benefited from the knowledge sharing and found the presentations useful for their operations.

V. Concluding Remarks

10. The participants expressed their appreciation to the Government of Mongolia, especially the Ministry of Road, Transport, Construction and Urban Development for hosting the Meeting and for the arrangements made by ADB.

Progress Report on Implementation Action Plan for the Transport and Trade Facilitation Strategy

I. Introduction

- The Sixth Ministerial Conference on Central Asia Regional Economic Cooperation (CAREC) in November 2007 endorsed the Transport and Trade Facilitation Strategy (the Strategy) that aims to upgrade six key transport corridors across the CAREC region, and simplify and harmonize regulations that govern cross-border trade in the region.
- The Seventh Ministerial Conference in November 2008 endorsed the Implementation Action Plan (the Action Plan). The Action Plan outlines priority investment and technical assistance (TA) projects on transport and trade facilitation for 2008-2017. The Action Plan focuses on: (i) about 24,000 km of regional roads, 20,000 km of regional railways, and 29 pairs of border crossing points along CAREC corridors; (ii) two ports (Aktau in Kazakhstan and Baku in Azerbaijan) and shipping (400 km between Aktau and Baku); and (iii) 42 airports with international air services (a corridor map and lists of the border crossing points and airports are in Appendix 1). The Action Plan envisages establishing national joint transport and trade facilitation committees (NJCs) and a regional joint transport and trade facilitation committee (RJC), which will support transport and trade facilitation in the CAREC region systematically and manage the implementation of the Action Plan.
- 3. This Progress Report (i) summarizes the achievements made during 2008–2009, and (ii) proposes the actions that help ensure timely implementation of the Action Plan.

II. Progress during 2008–2009

Α. **Transport Sector Performance**

- The year 2008 was the first year for implementing the Action Plan. About 900 km of corridor roads were constructed or rehabilitated, and about 700 km of corridor railways were improved.
- 5. In 2009, about 1,200 km of corridor roads are expected to be rehabilitated, which will bring the total cumulative length of improved roads to 2,100 km. About 1,200 km of corridor railways are also expected to be improved in 2009, bringing the total accumulative length of rehabilitated or electrified corridor railways to 1,900 km. The transport sector performance in 2008-2009 is shown in Table 1.

B. Strategy and Development Plans

- 6. Afghanistan. The Government in February 2008 approved the Transport Sector Strategy (2008–2013) under Pillar 3 (Infrastructure) of the Afghanistan National Development Strategy. The Strategy aims to promote national development and reduce poverty. The specific goals for the transport sector are: to (i) upgrade and maintain the ring road and international road corridors by the end of 2009; (ii) ensure compliance of Kabul International Airport and Herat Airport with the International Civil Aviation Organization's (ICAO) and the International Air Transport Association (IATA)'s requirements by March 2011 (including runway and other improvements at Herat, Mazar-i-Sharif, Jalalabad, and Kandahar); (iii) pursue public-private partnerships in building and operation of new road transport corridors to help integrate Afghanistan into the Middle East and South and Central Asia; and (iv) reduce transit time through Afghanistan by implementing cooperative border management and other multilateral or bilateral trade and transit agreements.
- 7. **Kyrgyz Republic**. The Government updated the Road Sector Development Strategy in 2008. As part of the country's Road Development Program (2009–2011) and the National Development Strategy for 2009–2011, the Strategy gives priority to reconstruction of CAREC corridors. In addition, the Government approved the law on toll roads on 5 November 2008, which is under consideration by Parliament. With Asian Development Bank (ADB) assistance, the Government prepared a draft law on public-private partnership (PPP) and is developing a transport sector master plan.
- 8. **Mongolia.** The Government formulated a Transit Mongolia Program, which aims to develop major regional transport corridors with e-customs and single electronic window. The priorities for 2009 are to (i) construct the western transport corridor (Corridor 4a) and the missing link of the central north-south road corridor (Corridor 4b), (ii) implement the Customs Modernization Project and pilot-test the joint border control with the PRC, (iii) prepare the regional logistics development project focusing on Corridor 4b, and (iv) conduct performance measurement and monitoring on Corridor 4b.
- 9. **People's Republic of China (PRC).** The Government approved the revised Medium-and Long-term Railway Network Plan on 31 October 2008 to stimulate economic growth in response to the global financial crisis. The revised Plan will expand the country's railway network to 120,000 kilometers (km) by 2020. It includes improving the railway lines in Xinjiang and Inner Mongolia autonomous regions, which forms part of the CAREC transport corridors.
- 10. **Uzbekistan.** The President approved the investment program for 2009–2014 on 12 March 2009.

B. Institutional Development

- 11. All CAREC countries successfully completed the diagnostic assessments of customs procedures with support from the World Customs Organization and started implementing customs reform and modernization programs.
- 12. A workshop held in Ulaanbaatar, Mongolia on 26 May 2009 discussed with stakeholders the establishment and strengthening of the national joint transport and trade facilitation committees (NJCs) or similar organizations and a joint regional transport and trade facilitation committee (RJC). The NJCs or similar organizations were established in all CAREC countries prior to or after the adoption of the Action Plan. Preparatory work started in May 2009 to

strengthen the NJCs (or similar organizations) and establish the RJC to support transport and trade facilitation in the CAREC region.

13. The Transport Sector Coordinating Committee (TSCC) secretariat has coordinated closely with other CAREC committees, especially the Customs Cooperation Committee (CCC) secretariat to assist in implementing the Action Plan.

C. Action Plan

- 14. The total number of ongoing or completed investment projects has been increased from 22 to 48 additional 26 projects during 2008–2009. Of the total number of investment projects, 76% are being implemented or completed an increase by 36%. Seventeen (17) TA projects are ongoing or completed (about 35% of the total number of TA projects—an increased by 26%).
- 15. Thirty-nine investment projects with a total amount of \$14 billion are programmed for 2008–2012. Among these projects, five major projects in a total amount of \$9.2 billion are under implementation.
- The Corridor 1b (Kazakhstan road segment). The corridor has the total length 2,450 km running from Korgas at the PRC border to Zhaisan at the Russian Federation border via Almaty and Shymkent. The total investment cost is estimated at \$6.6 billion for rehabilitating 2,237 km of roads. ADB, EBRD, IsDB, JICA, and World Bank are providing financing for the improvement. Public-private partnership (about \$2.2 billion) is expected in conjunction with EBRD technical assistance. The project started in 2009 for targeted completion by 2012. Rehabilitation of this segment, with the planned improvement of border crossing at Korgas and ongoing development of the high-tech logistics centers in Almaty and Aktobe, as well as the Khorgas Global Logistics Center in Xinjiang, PRC, will facilitate trade between Europe and East Asia.
- Corridor 1c (Kyrgyz road segment). The segment, which runs from Bishkek to Torugart at the PRC border, is an important transport route linking the Kyrgyz Republic and other Central Asian countries to the PRC. The total investment cost is estimated at \$300 million. ADB and IsDB are providing financing for the improvement. The Export–Import Bank of China is also considering the possibility of participation in financial support.
- Corridor 2 (Azerbaijan railway segment). The railway line from Baku to Beyuk Kesik at the Georgia border along Corridor 2 carries a significant volume of transit cargo of oil and oil products from Kazakhstan and Turkmenistan to European markets. The total investment cost is estimated at \$1.8 billion. The Government of Azerbaijan started upgrading the railway line in 2008 with World Bank assistance. ADB and EBRD are considering financing this railway line. This, with the ongoing improvement of the CAREC 2 road segment and border crossing at Beyuk Kesik, will increase the transport capacity of Corridor 2 in the country.
- Corridor 4 (Mongolia segment). Corridor 4a, connecting Yarant at the PRC border to Ulaanbaishint at the Russian Federation border via Hovd, will link the western region of Mongolia to both the PRC and the Russian Federation. The total investment cost of Corridor 4a is estimated at \$200 million. ADB is financing phase I of the project and is exploring cofinancing resources. Development of Corridor 4a is expected to be completed by 2014. In

- May 2008, JICA approved a concessional loan of about \$288 million to finance the construction of a new international airport in Ulaanbaatar.
- 16. Eleven projects were completed during 2008–2009, accounting for about 10% of the 112 investment and TA projects. This comprises one investment (AFG: Naibabad-Hairatan road), one regional TA (REG: Development of coordinated national transport policies), and nine country-specific TAs.
- 17. Four projects (3 investments and one TA) have been added to the Action Plan: (i) AZE IP 4: Construction of Baku international sea trade port complex, (ii) UZE IP 8: Construction of double-track electrified Yangier-Jizak section and single-line electrified Yangier-Farkhad section, (iii) UZB IP 5: Construction of Tashguzar-Boysun-Kumgurgan section, and (iv) AZE TA 3: Preparation of railway sector development program. One TA in Tajikistan was completed and became an investment project (TAJ IP 6: Vahdat-Yavan Railway Construction).
- 18. Two investment projects were deleted from the Action Plan. The Government of Afghanistan cancelled AFG IP 6: Rehabilitation of regional airports, Phase II, considering the negative impacts on traffic of the global economic crisis. KGZ IP3: Reconstruction of Taraz-Talas-Suusamyr road was deleted because it involves a feeder road.
- 19. The TSCC and CCC secretariats reviewed regional projects to simplify requirements for project financing, implementation, and monitoring. This has resulted in a clearer focus: 27 regional project comprising 4 investments (\$922.8 million) (reduced from 5 investments) and 15 RETAs (\$49.7 million) (reduced from 39 TAs). Four investment projects are (i) border crossing point infrastructure development, (ii) customs IT system improvement; (iii) logistics center development; and (iv) customs modernization and infrastructure development I (KGZ and TAJ). CCC will take lead in implementing these projects.
- 20. The total number of TA was reduced from 37 to 11, comprising 5 relating to the transport sector and 6 on trade facilitation and customs cooperation. The TAs relating to the transport sector comprises:
- REG TRTA 1: CAREC Transport sector support initiative;
- REG TRTA 2: CAREC Road subsector support initiative;
- REG TRTA 3: CAREC Railway subsector support initiative;
- REG TRTA 4: CAREC Airport and civil aviation subsector support initiative; and
- REG TRTA 5: CAREC Port and shipping subsector support initiative.

The TAs on trade facilitation TAs consists of:

- REG TFTA 1: Facility and process improvements at border crossing points;
- REG TFTA 2: Strengthening capabilities of national certification agencies;
- REG TFTA 3: Development of logistics centers and information hubs;
- REG TFTA 4: Working with the private sector in trade facilitation;
- REG TFTA 5: Integrated trade facilitation capacity building program; and
- REG TFTA 6: Simplified transit procedures and strengthening guarantee systems in the CAREC Region.
- 21. All CAREC countries monitored the implementation of the Action Plan and submitted to the TSCC and CCC secretariats the progress reports, which were prepared jointly by the CAREC regional coordinators, advisors, and focal persons. To address the need for monitoring

indicators, a meeting on Corridor Performance Measurement and Monitoring (CPMM) was held in Guangzhou, PRC on 23–24 February 2009. ADB and its partner forwarder/carrier and logistics association(s) in each CAREC country signed a memorandum of understanding on CPMM activities. Data collection by partner forwarder/carrier and logistics associations started in March 2009.

II. Updated Investment and TA Program

22. The updated Action Plan comprises 63 investment projects (\$24.1 billion) and 49 TA projects (\$74.1 million) (see Tables 2 and 3).

A. Project Costs and Numbers

23. The total amount for investment projects has increased by \$3.0 billion, from \$21.1 billion to \$24.1 billion. This is due to the cost increases for several projects. Roads have the largest investment requirement (53% of total), followed by railways (36%). For TAs, roads also receive the largest share (27%), followed by trade facilitation, logistics, railways, and airports (Table 2).

24. The total number of investment projects has increased from 62 to 63. Consolidating regional TAs resulted in a significant reduction in the number of TAs from 65 to 49 (Table 3).

25. The revised Action Plan matrix is in Appendix 2, and the list of projects planned for 2010–2017 is in Appendix 3.

B. Financing Plans

26. The CAREC countries will finance about 29% of the total investment cost. External sources will finance 26% and the private sector, mostly road and rail concession projects in Kazakhstan, will finance 31%. Ongoing projects constitute 93% of the total investment cost as 26 new investments have been entered the implementation stage during the last two years. The CAREC countries have actively sought external financing to fill the remaining financing gap (Table 4).



27. The revised financing plan expects that external sources will finance about 40% of the total TA cost, followed by the governments of CAREC countries (6%) and the private sector (1%). Ongoing or completed TAs constitute 24% of the total TA cost as 13 TAs have entered their implementation stage or completed during the last two years. The CAREC countries have obtained external financing commitment totaling \$29.9 million, which is \$1.5 million more than the total funding commitment at the start of the Action Plan. The CAREC countries have actively pursued external financing to fill the financing gap for new TA projects (Table 5).

I. Introduction

- 1. The Implementation Action Plan for the Central Asia Regional Economic Cooperation (CAREC) Transport and Trade Facilitation Strategy (the Action Plan) focuses on (i) about 24,000 kilometers (km) of regional roads, 20,000 km of regional railways, and 29 pairs of border crossing points along CAREC corridors; (ii) two ports (Aktau in Kazakhstan and Baku in Azerbaijan) and shipping (400 km between Aktau and Baku); and (iii) 42 airports with international air services. Six CAREC Corridors are shown in Appendix 1. Cross border points are listed in Appendix 2 and the airports are presented in Appendix 3. The Action Plan will be implemented on a rolling basis.
- 2. This is the first rolling plan covering a 3-year period (the Rolling Plan) from 2010–2012. The Rolling Plan will support transport sector reforms and institutional building, and will include 14 priority investment projects (\$1.7 billion) and 28 technical assistance (TA) projects (\$51.7 million).

II. Key Results

- 3. Four results parameters will be used to assess transport sector performance in implementing the Action Plan:
 - (i) Roads constructed or improved (km, cumulative from 2007);
 - (ii) Railways constructed or improved (km, cumulative from 2007);
 - (iii) Airports built or improved (no. cumulative from 2007);
 - (iv) Cross-border facilities improved (no., cumulative from 2007).
- 4. The performance indicators are shown in Table 1.

III. Investment and Technical Assistance Projects

5. **Investment Projects.** The Rolling Plan includes 14 priority investment projects, totaling \$1.7 billion (Table 2). The governments of Tajikistan and Uzbekistan is actively pursuing external financing of two investment projects (Asian Development Bank [ADB] financing for the Dushanbe-Tursunzade-Uzbek border road project in Tajikistan and Japan International Cooperation Agency financing for the Electrification of Marokand–Kashi–Tashguzar–Boysun–Kumgurgan Section) in Uzbekistan totaling about \$273 million. The 12 remaining projects are at

various stage of securing financing. The Government of Kazakhstan has requested ADB to consider financing of the Aktau-Beyneu road rehabilitation project.

6. **Technical Assistance Projects**. The Rolling Plan includes 28 priority TA projects, totaling \$51.7 million (Table 3). Two projects have secured or are securing financing, amounting to \$1.5 million, while the remaining 26 projects are at various stage of securing financing.



IV. Capacity Development

- 7. The CAREC countries will strengthen institutional capacity during 2010–2012. The Transport Sector Coordinating Committee (TSCC) will support the efforts of the CAREC countries, focusing on the following two aspects:
- 8. **Road safety.** Road accident is one of the major concerns. TSCC will continue to conduct training on road safety in 2010. TSCC will also assist the CAREC countries to develop a regional road safety program and strengthen national road safety programs, starting from 2010.
- 9. **Regional transport project implementation support.** The TSCC will conduct a series of seminars on regional transport project implementation, with the first one at ADB Headquarters in Manila in October 2009.

V. Implementation, Monitoring, and Reporting

10. The CAREC countries will be responsible for managing and monitoring the implementation of the Rolling Plan, and will report to the TSCC meeting and Ministerial Conference annually. They will prepare annual country progress reports (CPRs) in coordination with representatives of CAREC multilateral institutions and other development partners. The CPRs will include (i) transport and trade facilitation sector developments focusing on major actions, reforms, and institutional development activities; (ii) narrative descriptions of notable progress made during the review period, (iii) change, if any, in the implementation schedule, (iii) problems and difficulties encountered, and (iv) activities to be undertaken in the next reporting period. The CPRs will be submitted to the annual TSCC meeting. The Rolling Plan will be updated based on the CPRs and discussions during the TSCC meeting.


