





Terms of Reference CAREC Regional Training of Trainers Course on Free Trade Agreements

TA-6558 REG: Strengthening Knowledge and Capacities for the Design and Implementation of Free Trade Agreements Involving Central Asia Regional Economic Cooperation Countries

Name and type of the course:

Train-the-Trainers Upskilling Exercise

Objectives of the course, expected results:

This activity is a regional training program intended to train a limited number of experienced representatives from governments from each CAREC country, thereby further empowering them with technical training expertise and experience that they can integrate with their own local knowledge and experience so as to be able to disseminate it more effectively in their own domestic policy and institutional settings. International consultants, together with experts from the CAREC Institute and the ADB will deliver the training outputs in two phases, with the first being delivered online with pre-recorded videos lectures and the second phase being delivered in real time in the form of in-person workshops, covering major subjects identified as priority areas in the Capacity Needs Assessment of CAREC countries.

The result will be a team of newly empowered experts in each of the CAREC beneficiary countries able to support the broader capacity building efforts of the program and serve as resource persons as their governments prepare for future FTA negotiations, including with one another.

Expected number of participants:

2-3 participants per country. 20 to 30 participants in total.

Who should participate (possible agencies, level of participants):

Mid- and senior-level government officials responsible for trade negotiations, from CAREC countries. The nominated country participants are required to complete and attend all training sessions in both the online and in-person phases of the activity.

Certificates of completion:

After each online session, participants will have to pass a quiz. Participation at the in-person workshop will be made contingent on completion of all quizzes. The in-person workshop will conclude with a certificate ceremony where all participants will receive a certificate of completion.

Total of 12 online sessions of approximately 60 minutes each followed by a short online quiz for each session. Those who take the online training modules and successfully complete each quiz are invited to attend a two and a half-day in-person workshop that features 5 interactive sessions on various aspects of the materials covered in the online training.

In-Person Interactive Workshop (3 interactive exercises)

Attendance at the in-person workshop will be open to the same participants who were invited to participate in the online activities and who have successfully completed these online training modules and passed each of the 12 accompanying quizzes.

The in-person workshop revolves around three distinct interactive activities which will allow participants to apply the knowledge they have acquired in the first (online) phase of the Training of Trainers activity. To complete the interactive workshop activities, participants will work in teams, allocated on the basis of their home countries, and will have to work both together and with other teams in order to complete each activity. Trainers will be present to support each team and provide feedback, which is itself a valuable part of the learning exercise.

The workshop will take place over two and a half days.
