




General Profile: Transport Mode










Cargo Types Carried by Road

The transit speed when the vehicle is moving across a distance.




Speed With Delays (SWD)


The speed of the vehicle, including stoppage time, across a distance.

The stoppage time is caused by the list of activities indicated in the TCD file.


Relating Speeds to TCD Chart




Average Speed (Road)




Average Speed (Rail)




Speed Reliability (Road)




Speed Reliability (Rail)

Stop Analysis for Rail








Average Cost (Road)


Units in US\$/500 km




Average Cost (Rail)
