### Key Success Factors for Single Window Development

- Strong political will on the part of both government and business
- Legally enabling environment
- Strong lead agency as SW project champion
- Government-trade partnership
- International standards and recommendations
  - User friendliness and accessibility

#### Basic Models of Single Window

- Basic Models
  - Single Authority
  - Single Automated System
  - Automated Information Transaction System
- Financing
  - By state
  - By private sector
  - PPP
- Services (free of charge or paid on various payment schemes)
- No one-size-fits-all approach; depending on country situation and needs

Document Simplification and Standardization

Business/Political Process - Collaboration Between Trader and Government (UN/CEFACT Rec. 4, Rec. 18) and between government agencies, UN/CEFACT International Supply Chain Reference model, Business Process Analysis Guide, Unified Modeling Methodology (UMM), GFP Audit Methodology

#### Selection Criteria for SW Component

- Strong country ownership
- Enabling legal and policy environment (laws and resolutions for SW development)
- Readiness (ICT status and capacity, SW master plan and implementation action plan, etc)
- Technical and economic viability
- Positive due diligence results



#### Project Coverage and Information Request

- Portions of SWs of KGZ, MON and TAJ to be covered
- SW components:
  - >Investment needs for national SW
  - ➤ Linking national SWs
- Provide latest SW information to PPTA consultants:
  - ➤ Master plan/feasibility study: status of implementation
- ➤ Institutional and policy issues
- >IT systems used by participating agencies

#### Key Issues

- Regional interoperability: who leads? AZE?
- For countries not participating in the project, what is your timeframe for activating your Single Window? Are feasibility studies complete? Do they envision regional interoperability?
- Is funding in place to support Single Window development? Have Business Process Analyses been conducted?
- Is the business model agreed? Are lead agencies working well together?
- How can Single Window Working Groups be expanded/transformed into National Joint Transport and Trade Facilitation Committees?



#### Next Steps

- For countries participating in the Single Window component, please work closely with the PPTA consultants so that your needs can be fairly assessed.
- Please ensure that PPTA consultants are provided with the information requested in our 9 February letter.
- For countries not participating in the Single Window component, please share with us your plans to activate a Single Electronic Window and share data with principal trading partners.
- Propose a mechanism for identifying and resolving any legal and regulatory issues which might impede data exchange regionally.
