# TRANSPORT SECTOR STATUS REPORT UPDATE

Fifth Transport Sector Coordinating Committee Meeting (TSCC) on Central Asia Regional Economic Cooperation (CAREC), 15—16 March 2006, Urumqi, Xinjiang Uygur Autonomous Region, People's Republic of China

# I. Introduction

- 1. During the Fourth Transport Sector Coordinating Committee (TSCC) Meeting held in Bishkek, Kyrgyz Republic on 12–13 October 2005, it was agreed that TSCC's 2006 Work Program focuses on the following activities:
  - (i) Endorsement of an action plan for harmonizing transport regulations and simplifying cross-border transport procedures (Phase 1), to be implemented during 2006–2008.
  - (ii) Implementation of ADB's technical assistance for Facilitation of Transport Cooperation among CAREC countries (Phase I), which includes pre-feasibility studies of improving selected regional transport corridors.
  - (iii) Initiation of a study on improvements of transport sector funding and management.
  - (iv) Initiation of a study on restructuring and modernizing the railway subsector.

# II. Progress of Cooperation since the Fourth Ministerial Conference

# A. Fifth Transport Sector Coordinating Meeting

- 2. The Fifth TSCC Meeting was convened in Urumqi, People's Republic of China (PRC) on 15–16 March 2006 and was attended by delegations from CAREC countries and representatives of multilateral institutions (MIs) including the Asian Development Bank (ADB), United Nations Development Programme (UNDP), United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP), and the World Bank (WB). The Meeting was chaired by the Ministry of Communications (MOC), PRC and co-chaired by ADB (refer to Summary of Discussions in Appendix 1).
- 3. The participants welcome the delegation from the Islamic Republic of Afghanistan to attend the TSCC Meeting for the first time as a member of CAREC program. In accepting the invitation to TSCC, the Afghanistan delegation acknowledged the Central Asia Regional Transport Sector Road Map for 2005–2010, TSCC's 2006 Work Program, and other documents endorsed at previous TSCC meetings.
- 4. The participants decided to submit to the Senior Officials' Meeting the following results:
  - (i) Updated MI assistance pipelines for regional transport projects for 2006–2007.
  - (ii) ADB's technical assistance proposal for regional road funding and management.
  - (iii) A proposal to update the Central Asia Regional Transport Sector Road Map (2005–2010) by including the civil aviation subsector.

### B. Infrastructure Investments

5. Progress has been made in improving the regional transport network since the Fourth Ministerial Conference. Major investments include (i) Afghanistan: ADB approved a \$55 million loan for improving the Qaisar—Bala Murghab road and is preparing a \$140 million

loan for improving the north-south corridor, to be finalized in 2006; (ii) Azerbaijan: ADB approved a \$52 million loan for improving the east—west highway (Yevlah—Ganja and Qazakh—Georgian border sections) in December 2005 and the World Bank approved a \$200 million loan for improving part of the southern road between Alat and the Iranian border in January 2006; (iii) Kyrgyz Republic: the Islamic Development Bank (IsDB) approved a \$9.2 million loan for improving the Taraz—Talas—Suusamyr road (Phase I); (iv) Mongolia: ADB is preparing an investment project for developing the western regional road to link the PRC and the Russian Federation; (v) PRC: ADB is preparing an investment project to upgrade the Korla—Kuqa road in Xinjiang; and (vi) Tajikistan: ADB approved a \$29.5 million loan for rehabilitating the Dushanbe—Kyrgyz border road (Phase II).

- 6. At the Fifth TSCC Meeting, the delegation of the Kyrgyz Republic requested MIs to consider financing the investment project to develop the railway line linking the PRC and Uzbekistan via the Kyrgyz Republic.
- 7. It is recognized that the MI's assistance program for investment projects need to be updated from time to time as appropriate.

# C. Nonlending Activities

- 8. MIs continued to provide grant assistance to CAREC countries for regional cooperation. Major non-lending assistance include (i) Azerbaijan: ADB is helping the Government develop a transport sector development strategy; (ii) Kazakhstan: WB is providing technical assistance (TA) to prepare a transport sector strategy; (iii) Mongolia: the ADB-funded pre-feasibility study of the western regional road development was completed; ADB is helping the Government prepare a transport development strategy and the World Bank is preparing an infrastructure strategy; and (iv) Uzbekistan: ADB is helping the Government formulate a transport sector strategy. In addition, ADB is in the process of consultant recruitment under the TA for Facilitation of Transport Cooperation among CAREC countries (Phase I) and has initiated preparation of the TA for improving regional road transport funding and management. WB is financing a study to pilot transport corridor performance measurement in Central Asia.
- 9. It is recognized that MI's assistance program for non-lending projects need to be updated from time to time as appropriate.

# D. Other Regional Cooperation Initiatives

- 10. **Central and South Asia Transport and Trade Forum:** ADB approved a TA grant of \$950,000 for Subregional Economic Cooperation in South and Central Asia (Phase II). The TA was implemented from January 2006.
- 11. **Shanghai Cooperation Organization (SCO):** A consultation meeting was held among the heads of the delegations from SCO countries in Beijing on 21–23 December 2005. The meeting resolved a number of issues and paved the way for future successful negotiations of the Agreement among SCO member states on facilitation of international road transport. The fourth Negotiating Meeting is tentatively scheduled for April 2006.
- 12. **Central Asia Cooperation Organization (CACO):** It was announced in late 2005 that CACO merged with the Eurasian Economic Community.

# III. Next Steps and Monitoring of Results

13. In accordance with the Road Map Implementation Action Plan, the following activities will be undertaken by the Sixth TSCC Meeting scheduled for August 2006:

- (i) Update the Central Asia Regional Transport Sector Road Map by including the civil aviation subsector, and present the updated Road Map at the Sixth TSCC Meeting.
- (ii) Revise the action plan for harmonizing regional transport regulations and cross-border agreements (Phase 1), and present the revised draft action plan at the Sixth TSCC Meeting for review and approval.
- (iii) ADB will present the findings of the pre-feasibility study of improving selected regional road corridors at the Sixth TSCC Meeting.
- (iv) Update the list of MI's approved and planned regional investments and technical assistance projects for 2006–2007, and extend the list to cover 2008–2009.
- (v) Finalize and start implementing ADB's TA for regional road funding and management.
- (vi) Initiate the discussion of a study on restructuring and modernizing the railway subsector in CAREC countries.

# I. INTRODUCTION

- 1. The Fifth Meeting of the Transport Sector Coordinating Committee (TSCC) of the Central Asia Regional Economic Cooperation (CAREC) Program was convened on 15—16 March 2006 in Urumqi, Xinjiang Uygur Autonomous Region (UAR), People's Republic of China (PRC). Delegations from all eight CAREC countries participated in the Meeting. The Islamic Republic of Afghanistan was welcomed to its first TSCC Meeting as a participant. Representatives of the multilateral institutions (MIs) including the Asian Development Bank (ADB), United Nations Development Programme (UNDP), United Nations Economic and Social Commission for Asia and the Pacific (UN ESCAP) and the World Bank (WB) also attended. The European Bank for Reconstruction and Development (EBRD) and the Islamic Development Bank (IsDB) provided inputs to the Meeting. The Meeting was chaired by the Ministry of Communications (MOC), PRC and co-chaired by ADB. The agenda of the Meeting and the list of delegates are provided in Appendix 1.
- 2. The TSCC reaffirmed their commitment to regional transport cooperation, and agreed to continue working together to achieve the goals and strategic priorities set in the Regional Transport Sector Road Map for 2005—2010. The Afghanistan delegation in accepting the invitation to the TSCC, acknowledged the Central Asia Regional Transport Sector Road Map for 2005—2010, TSCC's 2006 Work Program and other documents endorsed at previous TSCC meetings.

# II. PROGRESS IN REGIONAL TRANSPORT COOPERATION

- 3. The TSCC reviewed the progress since the Fourth TSCC Meeting in Bishkek on 12–13 October 2005. Regional infrastructure investments and technical assistance projects approved, or in the program for 2005–2007 are listed in Appendix 2. The MI infrastructure investments for 2005–2007 amount to \$1678.0 million, and the MI technical assistance for 2005–2007 amount to \$13.5 million. It is recognized that the MI's assistance program needs to be updated from time to time, as appropriate.
- 4. The Kyrgyz delegation stated the importance of the PRC-Kyrgyz-Uzbekistan rail link project that would link the railways of PRC, Kyrgyz Republic, Uzbekistan, and Tajikistan and requested the MIs to consider inclusion of the full feasibility study in the regional investment program to be financed on a grant basis. In addition, the TSCC requested technical assistance in the area of public-private partnerships.

# III. HARMONIZATION AND SIMPLIFICATION OF CROSS-BORDER TRANSPORT PROCEDURES, DOCUMENTS AND REGULATIONS (PHASE I)

5. ADB made a presentation on the proposed action plan for harmonizing regional transport regulations and cross-border agreements in the road and railway sub-sectors in CAREC countries. The TSCC supported the proposed action plan framework and provided constructive comments. The Secretariat was requested to incorporate the comments and to send the revised proposed action plan to the TSCC focal points for further review by 15 April 2006. The CAREC countries will provide comments, through TSCC focal points to the Secretariat by 15 June 2006. The revised draft of the proposed action plan will be submitted to the Sixth TSCC Meeting for consideration and approval.

# IV. DEVELOPMENT AND MAINTENANCE OF REGIONAL TRANSPORT

- 6. The TSCC made country presentations on liberalization of the civil aviation subsector. The TSCC made comments on the WB report on the potential for liberalization of the civil aviation sub-sector. The WB made a note of the comments, and requested the TSCC focal points to submit any further comments after the Meeting. These comments will be incorporated into the final report and a proposed action plan prepared by the WB for the Sixth TSCC Meeting.
- 7. ADB made a presentation on the proposed regional technical assistance for regional road funding and management in CAREC countries. The TSCC members made comments and endorsed the technical assistance proposal for further processing.
- 8. The Central Asia Congress of Business Associations representative briefed the TSCC meeting on the WB financed Central Asia pilot transport corridor performance measurement study. The TSCC stated the importance of the objective of this study and the practical link to the proposed action plan for harmonizing regional transport regulations and cross-border agreements. The TSCC stated the need to expand the study, improve the methodology taking into consideration their comments and the need to involve the participation of relevant government agencies.

# V. OTHER INITIATIVES FOR REGIONAL TRANSPORT COOPERATION

- 9. ADB presented to the TSCC Meeting on the ADB supported Greater Mekong Subregion transport sector strategy up to 2015. The PRC delegation suggested that TSCC consider developing a similar transport sector strategy under CAREC. UNDP recommended that human development aspects such as prevention of HIV/ AIDS, drug and human trafficking be considered during the development of the transport sector strategy.
- 10. UN ESCAP presented to the TSCC Meeting on the status of the negotiations on the agreement between the governments of the Shanghai Cooperation Organization member states on facilitation of international road transport. The TSCC expressed appreciation to UN ESCAP and ADB for supporting the negotiation process, and requested both institutions to continue facilitating the negotiations in the future.
- 11. The Mongolian delegation presented to the TSCC Meeting on the course of the negotiations of the transit traffic agreement between the governments of the PRC, Mongolia, and the Russian Federation. Mongolian delegation requested WB and ADB to provide support for the future negotiations on this agreement among the three countries.

# VI. TRANSPORT SECTOR REPORT AND NEXT STEPS

- 12. The TSCC reviewed the draft transport sector report update and made comments. The TSCC made decision to submit the revised transport report update to the Senior Officials' Meeting (SOM) on 10-11 April 2006, demonstrating the following results:
  - Updated MI assistance program for regional transport infrastructure investments and technical assistance for 2006—2007.
  - ADB's technical assistance proposal for regional road funding and management.
  - The proposal to update the Central Asia Regional Transport Sector Road Map (2005–2010) by including the civil aviation sub-sector.

- 13. The TSCC will undertake the following activities for presentation at the Sixth TSCC Meeting:
  - Update the Central Asia Regional Transport Sector Road Map (2005–2010) by including the civil aviation sub sector, and present the updated Road Map at the Sixth TSCC Meeting.
  - Revise the action plan for harmonizing regional transport regulations and crossborder agreements (Phase 1), and finalize the action plan at the Sixth TSCC Meeting.
  - ADB will prepare and present the findings of the pre-feasibility study of improving selected regional road corridors for presentation at the Sixth TSCC Meeting.
  - Update the MI assistance program for regional transport infrastructure investments and technical assistance for 2006—2007, and extend the program to cover 2008—2009.
  - Finalize the technical assistance proposal, and subject to ADB management approval start implementing ADB's TA for regional road funding and management.
  - Initiate discussion on study on restructuring and modernizing the railway subsector in CAREC countries.

# VII. CONCLUDING REMARKS

- 14. The TSCC noted significant progress achieved in coordinating regional transport cooperation activities among the CAREC countries.
- 15. The TSCC expressed their appreciation to the People's Republic of China for agreeing to host the 5<sup>th</sup> TSCC Meeting and for the good arrangements extended by the ADB, MOC and the Xinjiang Communications Department.
- 16. It was agreed that the 6<sup>th</sup> TSCC Meeting would be held in August 2006 in Urumqi, Xinjiang UAR, PRC.

# CENTRAL ASIA REGIONAL ECONOMIC COOPERATION (CAREC) PROGRAM CRITERIA FOR THE CLASSIFICATION OF INVESTMENT PROJECTS AND STUDIES AS REGIONAL COOPERATION

# (Endorsed Version) 4<sup>th</sup> TSCC Meeting, 12-13 October 2005, Bishkek, Kyrgyz Republic

- I. The transport sector comprises the following sub-sectors: roads, rail, civil aviation, water, pipelines, and urban transport. The investment projects and studies classified as regional cooperation involve at least one of the following:
  - (i) The development or enhancement of policies, regulations, and agreements related to facilitating efficient movement of freight and passengers between more than one CAREC member countries.
  - (ii) The preparation of feasibility studies or designs of transport corridors linking more than one CAREC member countries.
  - (iii) The construction or improvement of transport infrastructure on the transport corridors linking more than one CAREC member countries.
  - (iv) Projects aimed at facilitation of transport logistics centers and information systems for monitoring transit freights with regional implications.
  - (v) National interventions in CAREC member countries (e.g. feeder roads to primary delineated transport corridors, sustainable road maintenance, human resources development) with regional implications.
  - (vi) Projects aimed at construction or rehabilitation (upgrade of technical capacities) of mechanical engineering facilities (enterprises for manufacturing and repair of rolling stocks) with regional implications.
- II. The investment projects and studies are classified as regional cooperation, if at least 30% of the following components are addressing regional issues:
  - (i) the total cost of investment projects; or
  - (ii) the total consulting inputs for studies.
- III. The investment projects and studies under the CAREC program cover the following countries: Islamic Republic of Afghanistan, Azerbaijan, Kazakhstan, Kyrgyz Republic, Mongolia, People's Republic of China (Xinjiang Uygur Autonomous Region), Tajikistan, and Uzbekistan.
