Rationale

- Border crossing point (BCP) is the major bottleneck - more than three quarters of waiting time and two thirds of costs incurred at the BCPs
- Complex procedures and repeated submission of same import/export information cost time and money
- Modernizing BCPs and streamlining procedures at BCPs will have the most efficiency gains

	• Focus on 29 BCPs along CAREC Corridors

Actions Required

 - Investment profile for each BCP
- Provide latest information on BCPs
 - Traffic (by volume, mode, and direction, for 2006-2010)
 - Trade (by good/commodity, import/export, and country)
 - Institutional and policy issues
 - Physical infrastructure
 - Cooperation arrangements with neighboring country
- SW components
 - Investment needs for national SW
 - Investment needs for interconnecting national SWs
- Provide latest SW information
 - Master plan/feasibility study: status of implementation
 - Institutional and policy issues
 - IT systems used by participating agencies

CPMM and TRS

- Due diligence
 - detailed information from Corridor
 Performance Measurement and Monitoring
 (CPMM) for each BCP
 - Time-release study (TRS) to be conducted by customs examines root-causes of delays
- Result management
 - CPMM provides regular coverage
 - Multiples TRS to verify results



RIBS Inception Meeting

- Confirming with countries lists of priority BCPs
- Country commitment to provide available supporting information (preliminary designs, cost estimates, and traffic data),
- Updates on executing and implementing agencies
- Secure permissions for consultants to visit the BCPs and planning dates for the visits
